ADVANCING THE MISSION

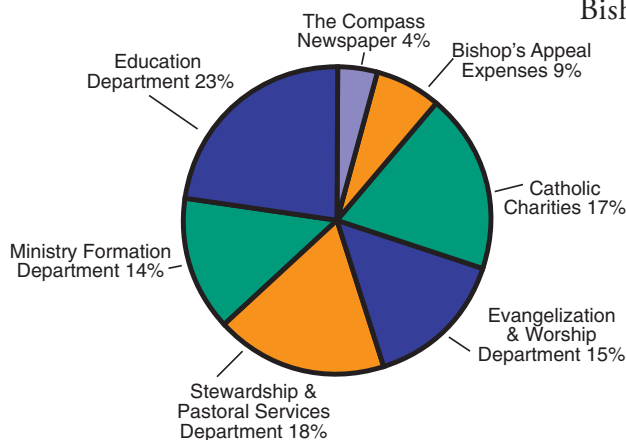
Since its inception in 2006, the Advancing the Mission Stewardship campaign has raised nearly \$40,000,000 and continues to help individuals, parishes, and our Diocese thrive and grow. The campaign helped fund five initiatives designed specifically toward planning for the future of parishes and the Diocese of Green Bay. Over 30,000 parishioners were involved in the campaign.

The four endowments provide grants to parishes and individuals in the areas of leadership development, evangelization, education, and priestly retirement care. This past year the campaign distributed more than \$300,000 to assist individuals, schools, parishes and ministries throughout the Diocese. We are thankful for the prayers and efforts of all who have supported the campaign and those whom continue to do so.



BISHOP'S APPEAL

Imagine being able to help a child learn about Jesus or being a lifeline of hope for someone struggling with the challenges of day-to-day life. Last year more than 32,000 people were able to help a child or someone in need of care by making a gift to the 2010 Bishop's Appeal campaign.

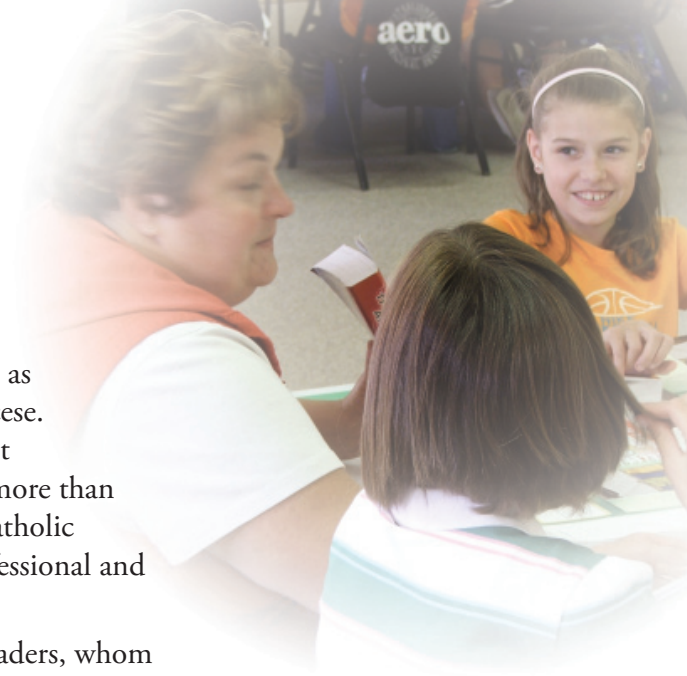


The Bishop's Appeal is an annual fundraising campaign conducted by the Catholic Foundation to benefit the ministries and services of the Diocese of Green Bay. These ministries help form and train new deacons, lay ministers and help Catholic Charities serve more than 45,000 people. Through the generosity of the people of Northeastern Wisconsin, the 2010 Bishop's Appeal was able to raise \$4,501,000.

LUMEN CHRISTI

We are truly blessed to have an endowment, such as Lumen Christi, that impacts so many lives in our Diocese. The Lumen Christi campaign was established to benefit Catholic education in 1988 and has since distributed more than \$16 million to parish religious education programs, Catholic schools and educational leaders to help fund their professional and academic development.

The campaign helps educate many educational leaders, whom in return help our Catholic youth receive the gift of knowing Jesus Christ. More than \$625,000 has been distributed this past year and to date the total value of the Lumen Christi endowment of the Catholic Foundation is more than \$12 million.



WORLD MISSION SERVICES



Did you know that for two-thirds of the world's people, the time still lies ahead when Christ will be born in their lives, their hearts and their souls? Through the activities of the Pontifical Mission Societies, the office of World Mission Services promotes global outreach to support evangelization efforts in over 1,250 mission Dioceses. In 2010, the Diocese of Green Bay disbursed \$298,743 to 37 missionary groups who participated in the 2009 Missionary Cooperation Appeal.

PLANNED GIVING

Planned Giving is the act of making a charitable contribution where the method and timing benefit both the recipient and the contributor. The recipient can make long-range plans while relying on a dependable source for future funding. And the donor can reap numerous benefits: income tax incentives, guaranteed lifetime income, reduction or elimination of estate taxes, and the satisfaction of making an important charitable gift to a worthy cause, to name just a few.

The possible ways of financing a Planned Gift are nearly limitless. They include:

- Paid-in-full, whole-life insurance policies
- Stocks, bonds, securities
- Real estate, including income producing property
- Works of art, special collections
- Retirement plans
- Mineral or timber rights
- Purchase of endowment life insurance policies
- Business assets

Planned Giving Options

CHARITABLE WILL BEQUEST — Bequeath gifts of real estate, cash, or other property as a last will and testament with the knowledge that it will benefit a charitable cause.

CHARITABLE LIVING WILL — Provide for eventual gifts of real estate, cash or other property knowing that all or part of the assets may be returned upon request.

CHARITABLE GIFT ANNUITY — Receive fixed annual payments for life which, for a period of time, may be partially free of taxes as well as an initial income tax reduction.


CHARITABLE REMAINDER TRUSTS — May bypass capital gains tax at the time the trust is created, and may receive federal estate tax savings.

CHARITABLE LEAD TRUST — Transfer assets to heirs with little or no real estate and gift taxes.

LIFE INSURANCE POLICIES — After a policy is no longer needed for its intended use, feel the satisfaction of giving to a charitable beneficiary.

ENDOWMENT LIFE INSURANCE POLICIES — Make a charitable gift to an organization which purchases policy in donor's name. When policy becomes self-funding, it is then designated to a beneficiary consistent with donor's wishes.

GIFTS OF APPRECIATED PROPERTY — Includes real estate, personal property, pension or retirement funds, and stocks and marketable securities.

Bishop's Greatest Needs Fund

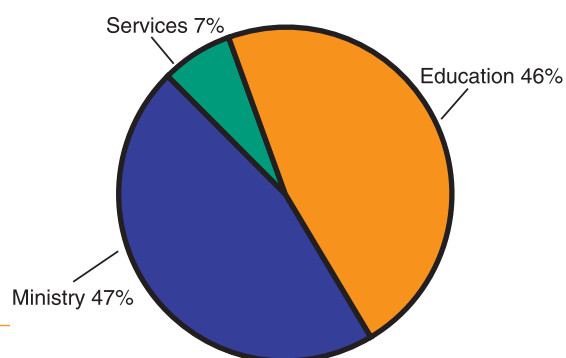
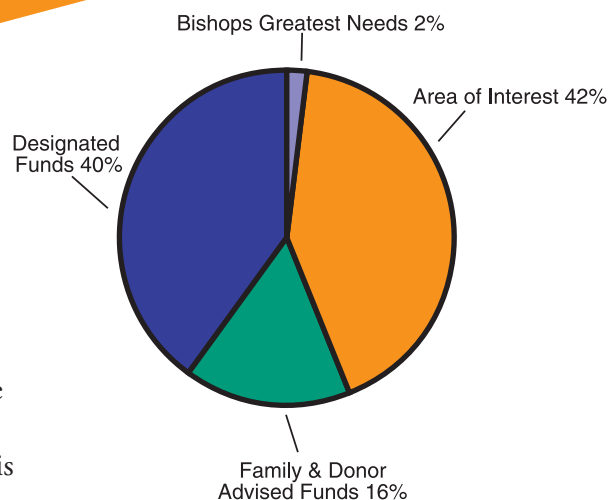

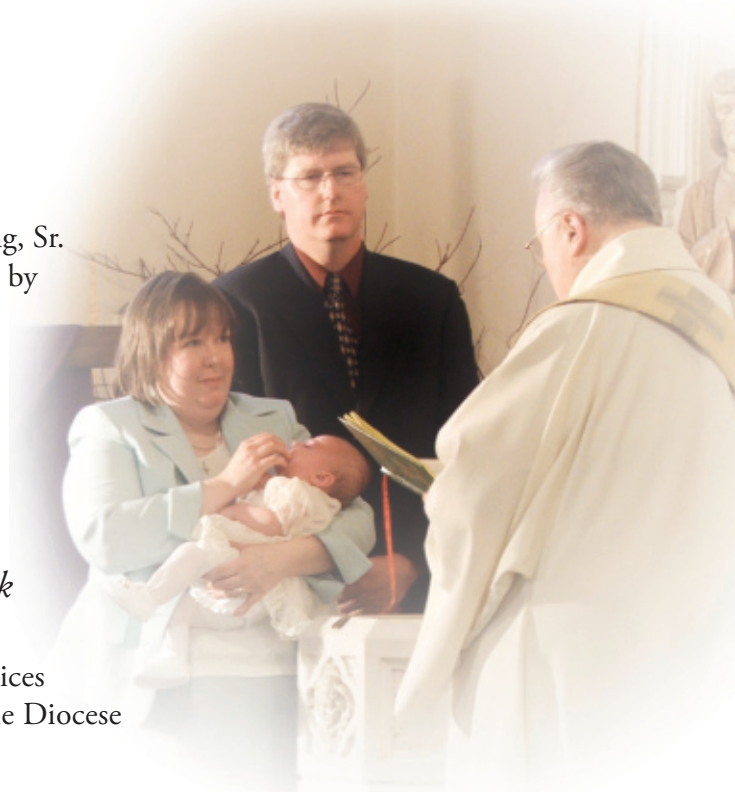

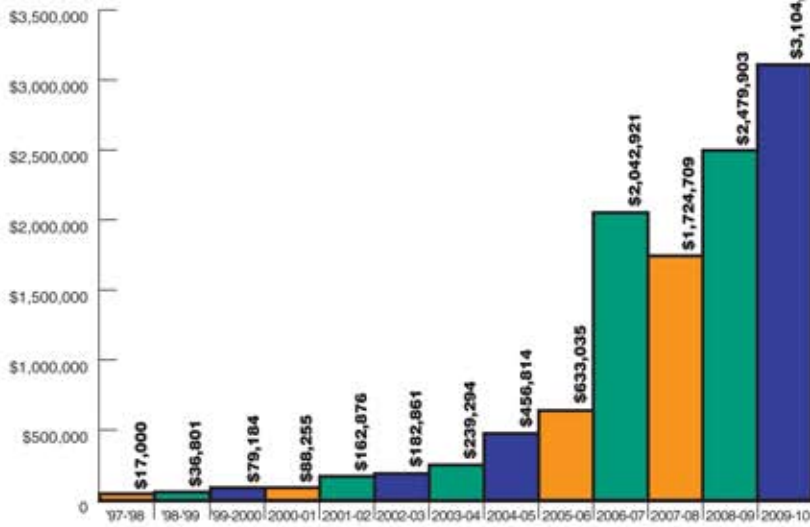

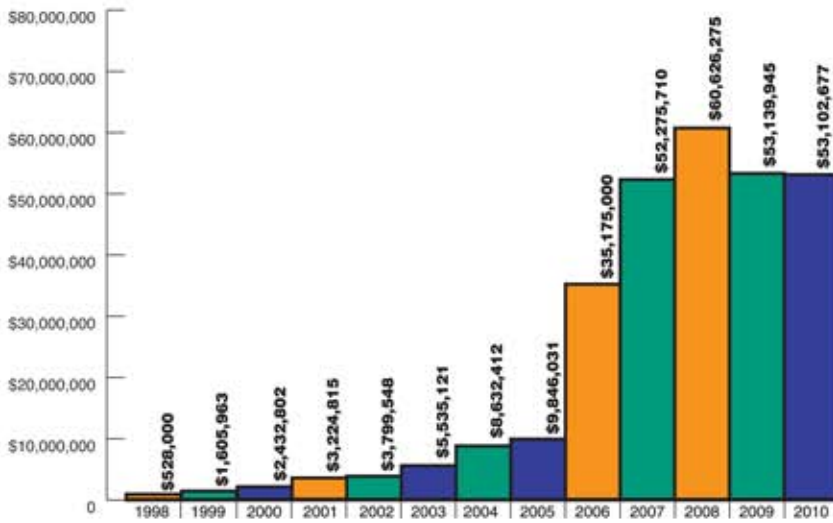
