Advancing the Mission




he Advancing the Mission Stewardship campaign, which began in 2006, helped fund five initiatives designed specifically toward planning for the future of parishes and the Diocese of Green Bay. The campaign allows us to provide grants to parishes and individuals in the areas of leadership development, evangelization, education and priestly retirement care. Over 14,000 parishioners were involved in the campaign and Advancing the Mission raised \$39,600,000 to benefit our parishes and Diocese. We are grateful for the prayers and efforts of all who have supported the campaign.

Bishop's Appeal

ach year thousands of people across northeastern Wisconsin come together and share their love of Christ by supporting of the Bishop's Appeal. The Appeal is an annual fundraising campaign conducted by the Catholic Foundation to benefit more than 300,000 people served by



the Church. These diocesan ministries impact children in Catholic schools and religious education programs, adults eager to learn more about the Catholic faith and over 40,000 people served through Catholic Charities. The 2009 Bishop's Appeal raised \$4,600,000 and was distributed to diocesan departments.



Lumen Christi

n 1988, the Lumen Christi campaign was established to benefit Catholic education. Since then more than \$3.5 million has been distributed to parish religious education programs; Catholic schools have received more than \$5.4 million; \$2.2 million has been given to educational leaders as scholarships to help fund their professional and academic development. As of June 30, 2009, the total value of the Lumen Christ endowment of the Catholic Foundation is more than \$9.6 million.

Helping yourself and the Church through a Charitable Gift Annuity

s senior priests in the Diocese of Green Bay, Fathers Leander Nickel and William Rickert wanted a steady income to help them meet their needs in retirement.

"When you get older you have more expenses for pills and all kinds of health problems," Father Rickert said.

They also wanted something safe with a good rate of return that would help the Church. So they were among the first to buy charitable gift annuities from the Catholic Foundation for the Diocese of Green Bay.

"I once bought some annuities from another place and I lost most of that money, about nine, ten years ago. They paid annuities for two years and after that they said they went broke," Father Nickel said. "Since then I buy annuities only from Catholic organizations."

Checks from the Catholic Foundation come regularly, they said. Plus they like knowing that after they die the money they invested will be used for good causes.

"The diocese knows where to put the money," Father Rickert said.

One of those places, Father Nickel, said is the education of seminarians, who as priests will serve the Church for decades to come.

In this Year for Priests they see a need to help the diocese look to the future and to remind people that "priests come from good Catholic families, not from a factory," Fr. Nickel said.

"We've been in these charitable gift annuities a long time," Father Rickert said. "Anybody who isn't in here should take note."

The Mount Tabor Center Changing Lives, One Kid at a Time

den Foord sees it several times a year. As high school students arrive at Mount Tabor Center in Menasha for the required Confirmation retreat several express their dissatisfaction — in attitude or word.

Then the activities begin, such as asking them to write their temptations on slips of blue paper that represent the river of temptation, says Foord, director of



the only staffed youth retreat center in the Diocese of Green Bay.

Youth then hear how the faith — Mass, where Christ is truly present, Scripture and service to others — can help them overcome temptation. They write these aspects of faith on cardboard pizza rounds and use them as stepping stones to cross the river, Foord says.

"Once they start into these activities, and hear the witnesses, you can see that God is working on them and they begin opening up. Many times students who are totally closed coming in leave saying, 'This was the best experience of my life' and giving us hugs and high-fives on the way out."

About a month after one retreat, a man told Foord that his niece had been involved with pornography, parties and drugs until going on the retreat. "We hear many stories like that," Foord says.

Two Catholic Foundation funds benefit Mount Tabor Center. The Clarence Wallace family started one years ago. The other, in memory of Sister Mary Jo Kirt, a former Center director, began last fall.

In 2003-04, Foord's first year, the center did 40 retreats for 1,000 students. Last year that had grown to 100 retreats for more than 3,000 students, requiring more staff and a larger budget.

"These fund disbursements are vital, especially as we've grown," Foord says.



Legacy Society 2008-2009

The Catholic Foundation Board of Directors recently voted to change the name of the Leadership Society to the Legacy Society. They thought it better captured the essence of what the group helps us to do. The main thing our almost 100 members have in common is their support of the Foundation's efforts to encourage others to leave a legacy. These legacies take many forms, outright bequests, charitable gift annuities, life insurance policies and various charitable trusts.

Surprisingly, in the United States today, more than 80% of individuals make a gift to charity each year, yet fewer than 10% make plans to continue their important help with a gift in their will or estate plan. They just don't consider leaving a legacy.

By taking the important step to remember your parish, school or other special charity with a legacy gift – you truly become the promise to future generations.

The promise is to share our faith in God and our Catholic values with those who come after us. It is with this purpose in mind we encourage an annual gift of \$1,000 to the Legacy Society to help others carry on their charitable intentions with a lasting legacy.




